#### City Manager report given by Wayne Ramsey for Scott Nay:

# Accountant Report Given by Wayne Ramsey for Ginny:

Spoke about Salary projections for 2025/2026 fiscal year that have been prepared. The department will be reviewing and preparing the remainder of their budgeted items for the new fiscal year. On March 3rd, Ginny had her final round of treatment. She was not able to attend the city council meeting, so Wayne gave her report.

# Public Works Report given by Wayne Ramsey:

Wayne started with the water plant operations and that they are doing fine. The Waste Water treatment plant had a few issues with the transducer, they are working to get a replacement with the help from McCaffrey Electric. The mixer in the decant tank is rebuilt and working again. Wayne had stated that the generator had a few hiccups in starting, Councilor Hawker had asked Wayne how old the generator was, and it is 9 years old. Chuck LaRue had asked Wayne when he was going to smoke test the lines. Wayne Stated that he will start smoke testing lines from Maple to Reedsford, then from Maple to 4<sup>th</sup> St. and 7<sup>th</sup> St, then south. Willy Burris gave kudos to Wayne for a job well done.

#### Fire Chief-Willy Burris:

Willy stated that he was on the command team that planned the memorial service for Lieutenant, Dana Glick of Greenacres fire. Full time EMT, Cody Martin has earned his Associates degree in paramedicine and completed the certification and now at MP ambulance. Willy met with the dispatch administrator and the Coos Bay Police Chief about issues with dispatching, since then there has been a vast improvement. MP Ambulance still continues to do transfers. Willy also expressed that there is now A landing pad in Camas Valley for Life Flight. Willy stated that he is working with Coos County Emergency Management for an updated community wildfire protection plan. Willy will be meeting with the Oregon Fire Marshal so she can hear the needs and take them to the Legislature.

# **Library Director Amy Bruno:**

Amy spoke about the success of the Bluey Party. There were 160 people that had attended. They had a Long Dog Scavenger Hunt and played Fancy Restaurant. The next big thing will be the Easter egg Hunt. There will be 2,000 eggs that need filled and donations are welcomed as well as help.

# Police Chief's report-Scott Robison

Chief Robinson brought one of the new ballistic shields to show. The funds were donated from Myrtle Pent First Christian Church. Chief Robinson is very grateful. There will be a shield class in May that two officers will attend. There are 2 new (to MP police Dept.) patrol cars that are now on the road. Officer Pierce was on a 911 call for a child that had injested Fentanyl and he admininisted Narcan and saved the childs life. Chief Robinson spoke about the distress Powers community is in with no police force. Mayor Clayburn was concerned if one of our officers was hurt while on patrol in Powers. Councilor Hawker asked Chief Robinson if he was ok with what Powers was asking. Councilor Ligons was just as concerned about the officers getting hurt while in Powers. Mayor Clayburn feels that this will put a strain on our department and is not in favor of this.

Having no further business for the City Of Myrtle Point, Mayor Clayburn adjourned the regular meeting at 7:16 P.M.
